#### Introduction

The annual conferences on Dublin Core and Metadata Applications bring together leading metadata researchers and professionals from around the world to share their experience in metadata development and application, and to deliberate on theoretical issues. DC-2007 in Singapore is the seventh in a series of conferences previously held in Tokyo (2001), Florence (2002), Seattle (2003), Shanghai (2004), Madrid (2005), and Manzanillo, Mexico (2006). It is being hosted by the National Library Board, Singapore, in cooperation with the Wee Kim Wee School of Communication and Information, Nanyang Technological University. Holding the conference in Singapore in 2007 is particularly significant considering the various initiatives in Singapore to implement metadata standards for e-Government and e-Citizen sites, and research projects undertaken by the National Library Board, National Heritage Board and the WKW School of Communication and Information on various aspects of metadata applications.

The conference theme "Application Profiles: Theory and Practice" is timely as more and more communities are exploring the use of metadata standards, including Dublin Core, for enhanced description and discovery of knowledge resources. Conference presentations seek to explore the conceptual and practical issues in the development and deployment of application profiles in various domains to meet the needs of specific communities of practice. Discussions and deliberation in the conference will provide the means to document the use of metadata within specific contexts. Emerging experience in the creation of application profiles reveal layers of complexity involved in combining terms from different metadata schemes and mixed abstract models.

The conference will be opened by Dr Vivian Balakrishnan, Singapore's Minister for Community Development, Youth & Sports and Second Minister for Information, Communications and the Arts. Keynote addresses will be delivered by Johannes Keizer, Team Leader for Semantic Standards, Knowledge Exchange & Capacity Building Division, Food and Agriculture Organization of the United Nations, and Zhang Xiaoxing, Deputy Director, National Cultural Information Resource Center of China.

A total of 10 papers and 6 reports have been selected for presentation by an international panel of reviewers. Five paper sessions are organized around the following themes: conceptual modeling; application profiles—issues and practices; identification, registries and reuse; and metadata generation and integration. Full papers report innovative original work in detail or provide critical, well-referenced overviews of key developments or good practice. Project reports describe specific models, application, or activity in a concise format. Three special sessions will also be conducted on the topics of ontology modeling using topic maps, RDA, and Identifiers. The pre-conference tutorials cover areas of semantics, syntax, vocabularies, and application profiles while post-conference seminar will deliberate on metadata for the Semantic Web.
